1373/2024 Chair's Welcome & Announcements

Cllr. Edwards (Chairman) welcomed residents to the Annual Meeting of the Parish Council and delivered Health and Safety housekeeping rules. No recording of the Meeting took place.

Social distancing and COVID - 19 measures were observed, such as ventilation.

1374 Public participation

A resident stated that they had attended the Planning Committee Meeting 13th May 2024 at Bodmin regarding the hearing of Planning Application PA23/10388 and had noted the voting result.

A resident mentioned that parking outside the Recreation field on match days was restricting access for emergency vehicles and proving difficult for private vehicles to pass. 1381 A Report from Cornwall Councillor Martin Worth


Cllr Worth has been appointed as one of the 10 Cabinet Members supporting the 570,000 residents of Cornwall.



A Cllr Sally White - Maintenance

The weeds in the Parish Pound have been strimmed and cleared.

Litter was noted at the quay due to increased activity and Cllr White suggested that any Councillor visiting the quay could look out for and clear any litter.

One of the picnic benches has been dragged to a new location. Councillors noted that a permanent placing or concreting in of the bench would not be done due to the planned developments at the Recreation Field.

Councillors **Resolved** to note this report.

B Cllr Malcolm Fletcher – Climate and Ecological Emergency

Cllr. Fletcher provided the following summary read by the Parish Chairman.

- 1. Swift boxes. The three swift nesting boxes purchased by BOTTHER, along with a swift calling system, have now been installed in St Mary's Church bell tower. We are hoping that eventually these iconic, but now endangered, birds may return to our Parish. Many thanks to residents Wayne John and Lisa Cooper for their work to install the boxes, and to St Mary's for hosting the boxes.
- 2. **Low Mow May**. Cormac have slightly modified *Plantlife's* campaign of No Mow May. They are only cutting grass areas for reasons of accessibility, safety for motorists and walkers, and sports pitches during May. This is to help reverse the catastrophic decline of all insect species, but of pollinators, in particular. That is why the A388 roundabout has been left to bloom by them. We also intend to leave a large area in the centre of the playing field uncut this month. It looks attractive with its carpet of daisies and buttercups. This will in no way impede residents' ability to enjoy the green open space we now have. The football pitch and the area in the play area will continue to be cut.
- 3. **Lizards!** Our contractor, Ally, tells me you can see common lizards in the car parking area of the field! You will have to be very quiet and patient to see them. Best chance to see them will be on a sunny day when they are basking in the sun. They are quite harmless and are one of our two species of lizard in the UK (the other is the sand lizard). They are viviparous, which means they have live-young, unlike the sand lizard which lays eggs.

C Cllr Mervyn Ellis – BOTHER

Walk/Cycleway

Margaret Matthews contacted Adam Warden (CORMAC) to enquire about his investigation into possible route sections in the region of Roods Corner. The news was disappointing.

- There is a disparity between information on the Land Registry and the deeds held by
 the owner of Woodside Stables concerning the exact width of the land which she had
 suggested could be made available for a path (between the A388 and Treledan). If
 the Land Registry details are the correct ones, the width of the area would fall short
 at one end.
- The owner of the land fringing Roods Corner itself (on the south-western corner)
 reiterated his earlier opposition to allowing a section of path there. Unless Cllr Worth
 has spoken to him subsequently and received a more favorable response, or unless
 CC is willing to make a compulsory purchase order, it seems this option will not be
 viable.

The route that CORMAC looked at would have been by far the simplest and cheapest. There are other options of course, and hopefully CC will be willing to explore these further, especially as cycling is apparently its top priority in terms of transport strategies.

Climate Change, Biodiversity and Farming

Margaret and Malcolm went to Calstock to see a film about successful regenerative farming projects across the UK called 'Six Inches of Soil'. One of the farms featured was on Bodmin Moor. The showing was very well attended, and local farmers pursuing similar goals were available to answer questions afterwards.


1390 Correspondence
