1399 A Report from Cornwall Councillor Martin Worth

Cllr Worth announced that he had been appointed as one of the 10 Cabinet Members supporting the 570,000 residents of Cornwall. The appointment in Cornwall Council is from the 1st June 2024. The position works alongside the ongoing commitment to the division of Saltash Trematon & Landrake.

Due to pre-election protocol, Cllr Worth was unable to comment on any other issues, other than to mention that the Tamar Crossings project is on hold until after the 4th July 2024 and that the Cornwall Council Cabinet were working on drafting a 10-year strategy in dealing with Travellers' sites.

Cllr Smith asked how much travellers were expected to pay for a pitch when they arrived on site. Cllr Worth would find out the cost and report back to the Parish Council.

1403 Recreation Field

Cllrs Edwards (Chairman) and Cllr Fletcher met with the grass cutting contractor to discuss cutting through a new access point into the old dog walking field. The Parish Council may have access to the field in the near future. Discussions are ongoing. Obviously, it would enable residents to let their dogs off of their leads for the entire length of the car park and then straight into the dog walking field through the new access point. The gate at the bottom of the car park would be relocated to the end of the mound/bund area that would effectively seal the car park and dog walking field off from the remainder of the Recreation Field.

The Recreation Field would remain a facility for dog walkers, but all dogs would have to be kept on a lead.

Security improvements to the main entrance gate were discussed. Additional seating for the area was also discussed and would be further dealt with at the next Public Meeting on 24th July 2024.

Saltash United Junior Football Club (SUJFC) were now playing fixtures again at the Recreation field football ground. A list of fixtures would be provided for the Clerk for purposes of rental charges. The old disused goal posts would be removed and disposed of.

Cllr Edwards (Chairman) stated that in negotiating with Ally Hill (Contractor) grass cutting for the football pitch would also be complemented by Wayne Hambly (subject to provision of personal credentials, risk assessment and evidence of Liability insurance cover).


B Climate and Ecological Emergency

Cllr Fletcher reported -

Cormac cut Hatt Roundabout for the first time this year on 18th June. This is in line with Cornwall's Nature Recovery Plan which aims to halt and reverse the decline in biodiversity in Cornwall for the health and wellbeing, and commercial benefits it will bring for the community.

Cormac is now delaying the first cut of roadside verges until the end of May/early June in order to allow wildflowers to bloom and provide habitats for pollinators and wildlife corridors to link up isolated habitats. The only exceptions to this will be where there are safety concerns. BFPC is pleased that Cormac have finally adopted this approach which it advocated back in 2018.

There have been concerns that the village approaches have looked "untidy" and "uncared for." It is now widely recognised that nature suffers when, with the best of intentions, we try to tidy it up by cutting and strimming everything to bowling green standards. We care for the environment when we allow it to thrive, not by tidying up the rough edges. We would do well to remember that as a species we live precariously on the top floor of a biological house of cards which is supported by invertebrates and micro-organisms. If we neglect or destroy them the whole edifice collapses.
