1409/2024 Chair's Welcome & Announcements

Cllr Edwards (Chairman) welcomed residents to the Public Meeting of the Parish Council and delivered Health and Safety housekeeping rules.

1410 Public participation

A resident asked about the proposed Automatic Number Plate Recognition (ANPR) system intended as an alternative to toll booths on the Tamar Bridge, and any likely cost to the motorist. Cllr Martin Worth explained the press release from SE Cornwall Community Area Partnerships (CAPs) regarding the (ANPR) proposed scheme (see below at item 1415).

1415 A Report from Cornwall Councillor Martin Worth

Cllr Worth reported regarding the (CAPs) update –

Members of the Tamar Bridge and Torpoint Ferry Joint Committee have welcomed the findings of a report into the introduction of Open Road Tolling as a vital next step in their aims of improving traffic flow and reducing journey times on the Bridge and the Ferry.

The investigation into the potential for introducing Open Road Tolling (ORT) at the crossings is part of the Tamar 2050 programme which is looking at new ways of funding and operating the Tamar Bridge and Torpoint Ferry.

The report, which was produced by consultants following extensive consultation with key stakeholders, concludes that it would be possible to introduce ORT at both crossings. The use of Automatic Number Plate Recognition (ANPR) rather than the current system of tolls booths would help to reduce queuing and traffic emissions, and improve journey times, as well as bringing economic benefits over the long term.

The report notes that significant highways work would be required where the Bridge joins the A38 Parkway. Designing and implementing these changes, together with other measures needed to support the introduction of the new system, could result in

costs of between £8.7m and £16.2 million depending largely on the preferred highway configuration option. It suggests that further work is required to develop a detailed business case which can then be used to support bids for external funding for the scheme.

Supporting the recommendation to commission a further report which includes an outline business case and funding strategy for ORT, Joint Chairs Martin Worth and Jon Dingle, said "The Joint Committee is committed to the principle of Open Road Tolling".

"During the past few months, we have secured the support of the Peninsula Transport Board which has now formally recognised Open Road Tolling at the crossings as a strategic project. We also continued to lobby the previous Government to provide financial support for the crossings. Following the general election, we are already engaging with the new MPs in Cornwall and Plymouth and will be seeking their support in pressing our case with the new Government.

"In the meantime, however, we need to continue with developing our plans to introduce Open Road Tolling at the crossings so we are in a strong position to bid for funding in the future."

At its March 2024 meeting, the Joint Committee resolved to meaningfully explore the possibility of toll abolition. Addressing the highways issues associated with introducing Open Road Tolling at the Tamar Bridge would support the technical feasibility of toll abolition, which would require an Open Road without Tolls.

Following the meeting, a Phase 2 Open Road Tolling Study will be commissioned with the costs met from existing budgets. The study will include an outline business case and funding strategy.

Cllr Worth also mentioned separate items concerning the 'cross-party' white paper which would be a Cornwall wish list reflecting the new Devolution deal for Cornwall, and the Safe A38 package would be revisited.

Application PA24 / 03984

Proposal Proposed new dwelling set within the private land

ownership grounds of Villaton Barton. Intended to allow multi-generational family occupancy, and to remain

dependent on and tied to the main host dwelling.

Location Villaton Barton Hatt Saltash PL12 6PP

Grid Ref 239001 / 62285

The Applicant advised Councillors that the current application is a smaller scale sustainable development than the previous submission PA23 / 07736 (refused 12.1.2024) by the Planning Development Officer. There is no intention of the proposed new development being sold outside of the immediate family, and that the Annexe will assist with family social care needs.

The Planning Development Officer advises that a single storey extension Annexe (not separate building) would be acceptable.

Parish Councillors agreed with this comment submitted by the Applicant and would support the revised Application subject to this condition, whilst noting the comments from Planning Development. Cllr Fletcher added that the

proposed multi-generational development would improve the appearance of he area (within existing settlement and not open Country development).

Consideration was given to the disruption of the Villaton Hamlet, and lanes, on whilst building works were underway, and whether any future development at Villaton Barton would increase traffic activity.

Cllr Willey (Vice Chair) proposed, Cllr Fletcher seconded support.

Councillors VOTED 5 Support, 1 abstain

The Council **Resolved** to support Planning Application PA24 / 03984 subject to the condition that the 'annexe' remains integral and NOT a separate building.

Cllr Edwards (Chairman) returned to the Meeting.
