- The Secretary of State has not yet taken a decision regarding the amount of increase to the Tamar bridge tolls and tag crossing fee.

- Safer Cornwall Project has a new Police Inspector, Insp. Ned Bowie, appointed for the Liskeard/Looe/Callington area and he will attend (CAPs) meeting in future.
- Peninsula Transport are carrying out a complete transport plan with a consultation ending 13th March 2025.
- The Saltash Tunnel Lane improvement works are progressing.

Cllr Smith enquired as to whether lorries could be rerouted through St Germans in order to avoid the A38 railway bridge at Trerulefoot. This matter is under consideration.

Proposal Application for proposal in principle for the construction

of up to 2 dwellings (minimum of 2, maximum of 2)

Location Sunnyside Botus Fleming Saltash Cornwall

Grid Ref 240601 / 61284

Cllr Fletcher referred to the number of comments that had been made on the Planning Portal viz- 10 in support of the Planning Application and 9 against the development.

It was noted that of the 10 supporting statements, only one was made from a resident in the immediate vicinity of the proposed development. A further supporting letter was from a resident of Botusfleming not in the immediate vicinity of the proposed development. The remaining letters of support were from people who did not live in Botusfleming. Eight of the comments were very similar in content.

In contrast, 5 of the 9 comments against the development were from residents in close vicinity to the site, three more were residents of Botusfleming. The remaining objector lived outside the village but had grown up there.

Overall, the Application did not mention specific details regarding dimensions of the properties. The applicant had previously gained permission to build a large barn on the site, claiming it was essential for the storage of fodder for the sheep kept there. However, the new application would necessitate the demolition of the barn, begging the question whether it was ever really needed. The application did not meet the criteria for "infill."

National Landscapes responded that the proposed development would have a detrimental effect on the current setting and current natural beauty setting. Councillors noted all the above points.

Cllr Fletcher proposed, Cllr Venables seconded NOT to support PA25 / 00303. All agreed.

The Parish Council **Resolved** not to SUPPORT Planning Application PA25 / 00303

1515 Recreation Field

Cllr Edwards (Chairman) has been requested to attend a Community Capacity Fund meeting in Truro. The precise reason for the meeting is not known.

Cllr Fletcher noted that the cherry tree saplings growing at the Recreation field mentioned during recent meetings would be relocated to more suitable positions.

Cllr Edwards (Chairman) thanked Richard Taylor for the preparatory work carried out with the VE Day celebrations in mind. Maintenance costs amounted to £126.52 with expenditure being met from the maintenance budget (see Item 1490 - 22nd January 2025).

1518 Correspondence

Councillor stated that he had served the Parish since 2017, particularly mentioning his involvement in Climate & Ecological Emergency issues and was also prepared to carry on to act as the Parish Tree Warden. Beyond this, Councillor Fletcher would carry on with a healthy interest in Parish affairs and look forwarded to the progress and the plan to build a Community Hall.

Everyone gave Councillor Fletcher a round of applause and thanks for the dedicated work that he had carried out in the Parish for the past 8 years.

- (ii) Following a request from a resident for the Council to add a 'passing sign' by the water meters leading up from the Botus Fleming Church Hall crossroads, the Parish Clerk would seek advise from the Highways Engineer (Cormac) Will Glassup and arrange a site inspection.
- (iii) The Parish Council noted the Motion from Redruth Town Council concerning the proposal that Cornwall Council consider a much fairer way of proportioning the proceeds from the new second home Council Tax premiums, so that all areas have equal benefit reflected in their precepts, and not just those areas with busy tourist locations. Councillor Fletcher proposed, Councillor Smith seconded

support for the Motion. All agreed. The Parish Clerk to relay the Motion dec to Redruth Town Council.
